AFFIDAVIT FOR ARREST

Georgia, BURKE County

Personally appeared YARBROUGH, SAMUEL TY, authorized by law to issue Criminal Warrants, who on oath says that to the best of Affiant's knowledge and belief ARBERY, AHMAUD MARQUEZ did, in BURKE County, Georgia, commit the offense of OBSTRUCTION OF LAW ENFORCEMENT OFFICERS - MISDEMEANOR between the hours of 17:30 on 2018-10-23, and 19:17, on 2018-10-23. The place of said offense being 100 BLOCK OF PERSIMMON DRIVE WAYNESBORO GA 30830 and against the Laws of Georgia. Said offense being described as: On October 23, 2018 at approximately 1730 hours, I Deputy Samuel Yarbrough, was dispatched to the residence next to 125 Persimmon Drive for suspicious persons. Upon arrival, I made contact with the complainant, Anquinta Jackson, who stated there were three individuals inside of a vacant trailer. I (Dep. Yarbrough) entered through the rear door and heard multiple voices detected an odor of burnt marijuana coming from inside the trailer. I observed a black male sitting at the front of the trailer and took flight when I (Dep. Yarbrough) announced "Stop Police," through the front door. I (Dep. Yarbrough) pursued the three subjects, and detained one black male in the front yard of 197 Persimmon Drive. The subject I (Dep. Yarbrough) detained stated his grandmother lived at the residence of 197 Persimmon Drive. After further investigation it was found that Daerick Towns (15 years of age) was with Ahmaud Arbery (24 years of age) and Octavious Herrington (15 years of age). I (Dep. Yarbrough) spoke to Mrs. Jackson, who identified all three subjects, by clothing descriptions, visual. Mrs. Jackson identified one of the subjects, Octavious Herrington, as her son. All three offenders were placed in custody and both juveniles were turned over to their guardians. A search of the area in the trailer, in which the subjects were seen, there were not any narcotics or firearms found.

NARRATIVE

On October 23, 2018, at approximately 1730 hours, I Deputy Samuel Yarbrough, was dispatched to 125 Persimmon Drive for suspicious persons. Upon arrival, I made contact with the complainant, Anquinta Jackson, who stated there were three black males, identified by shirt color, inside the vacant trailer north of her residence. Jackson stated one male wore an orange shirt, another wearing a grey shirt, and the last male wearing a black shirt. I approached the opened rear door of the vacant trailer and detected the odor of marijuana and heard multiple voices coming from the interior of the residence. I observed a black male sitting at the front of the trailer and ordered him to, "Let me see your hands" and he and the other occupants took flight through the front door. I gave chase and detained one black male, wearing an orange shirt, in the front yard of 197 Persimmon Drive. Deputy Clark (203) arrived on scene and I advised the two remaining subjects fled into the woods on the Westbound shoulder of Persimmon Drive. Deputy Clark advised he observed two black males walking southbound on Persimmon Drive and I advised him to detain them. After further investigation, it was found that Daerick Towns (15 years of age) was with Ahmaud Arbery (24 years of age) and Octavious Herrington (15 years of age). I spoke to Mrs. Jackson, who identified all three subjects by clothing descriptions. Mrs. Jackson identified one of the subjects, Octavious Herrington, as her son. Herrington and Towns both identified the third offender as Ahmaud "Quez" Arbery. Both juveniles were turned over to their guardians and Arbery was placed into custody and booked into the Burke County Detention Center for Obstruction of Law Enforcement Officer. A search of the area in the trailer, in which the subjects were seen, there were not any narcotics or firearms found.
