NARRATIVE

I gave chase and detained one black male, wearing an orange shirt, in the front yard of 197 Persimmon Drive. Deputy Clark (203) arrived on scene and I advised the two remaining subjects fled into the woods on the Westbound shoulder of Persimmon Drive. Deputy Clark advised he observed two black males walking southbound on Persimmon Drive and I advised him to detain them. After further investigation, it was found that Daerick Towns (15 years of age) was with Ahmaud Arbery (24 years of age) and Octavious Herrington (15 years of age). I spoke to Mrs. Jackson, who identified all three subjects by clothing descriptions. Mrs. Jackson identified one of the subjects, Octavious Herrington, as her son. Herrington and Towns both identified the third offender as Ahmaud "Quez" Arbery. Both juveniles were turned over to their guardians and Arbery was placed into custody and booked into the Burke County Detention Center for Obstruction of Law Enforcement Officer. A search of the area in the trailer, in which the subjects were seen, there were not any narcotics or firearms found.
